1. Commission 10% commission on sale
2. **NO Photography** will be accepted, no over painting of photographs in any medium will be accepted.
3. Members Only Exhibition, you must be a paid-up member.
4. Display will be at the discretion of Exhibition Manager.
5. Paintings to be the original work of the Artist. Artists must be aware of, and not breach copyright laws.
6. All care taken but no responsibility taken by CPAS for damage, theft or loss.
7. Insurance for paintings is the responsibility of the Exhibitor.
8. CPAS decision on disputes shall be final.
10. You will allow reproduction for promotional purposes, display or for media use.
11. Diptych & Triptych paintings must be joined together to make one image, **not** 2 or 3 separate images.

**All works must be:**

1. Framed to exhibition standard:
  - o attaching D hooks 10cm from top of painting.
  - o place string generally one quarter to one third of way from top of painting.
  - o have labels already filled out and attached to back of artwork on bottom left hand side.
  - o please clean glass and frames of dirt and dust, as it is not our job to do this.
  - o frames that are damaged, scratched & generally not up to standard, will be rejected.
2. Thin edged unframed canvases **will not** be accepted.
3. Payments are to be completed by Close of Entry.
